TERMS AND CONDITIONS of EDUardo SOCIAL IMPACT PROGRAM

Definitions

- Participating institution university, foundation, other NGO or GO that applies to participate and selected to participate in the Social Impact Program
- **Learning project** educational effort targeted by the use of EDUardo learning services in the Social Impact Program
- Individual learner individual participant of the Learning project
- Board of the Social Impact Program group of individuals who are invited and appointed by EDUardo to make the decision about the participants of the Social Impact Program. The participants of the board are announced and introduced on the webpage of the Social Impact Program.
- EDUardo EDUardo Zrt. as the organizer of the Social Impact Program

Conditions of Social Impact Program

- Application process: participants of the Social Impact Program are selected based on the written application of institutions. Applications can be submitted on the website of EDUardo.
- **Application deadline** to the actual round of the Social Impact Program is announced on the website of EDUardo.
- **Selection process** is coordinated by the board of the Social Impact Program. Selection is based on the expected impact of the applicants' learning projects by using the free service of EDUardo.
- Not-for profit focus is required: the participating institution cannot use the free service of the Social Impact Program to generate revenues of any forms, including but not limited to requesting an access fee from the individual participants.
- The **communication language** of the program is **English**.
- The participating institution cannot transfer its program related rights to a 3rd party.
- The free service of the Social Impact Program cannot be exchanged to money.
- The maximum number of individual participants of the learning project is 1000 (one thousand).
- The participating institution can **select 2 learning modules** for a class of participants. The participating institution's learning project can have multiple classes.
- EDUardo offers **free access** to the **selected content of its online learning catalogue** to the participants of the Social Impact Program.
- The participating institution is responsible for settling any tax that is applicable after the use of free services at the countries where the participating institution operates.
- The participating institution can appoint a teaching staff (maximum 20 people) who
 will have access to the system, the trainers' instruction materials and the individual
 learners' progress statistics.
- As part of the free service, the participating institution can request a maximum of 3
 hours of online onboarding for teachers and administrators of the learning project.
- The access period to the learning modules is 4 months (120 calendar days).

- Administration of accesses: individual accesses are administrated by the appointed administrator of the participating institution in EDUardo's user management system. The user identification is done by the e-mail address of the individual learner.
- The participating institution acknowledges that an individual participant of the learning program is not allowed to share the access codes to the EDUardo learning platform with other individuals or entities. In the case that the share of access codes with 3rd parties is detected, EDUardo has the right to revoke access of the given participant. If this issue happens multiple times, EDUardo has the right to deny any further free service from the participating institution.
- The participating institution acknowledges and agrees that EDUardo can post about the learning project in social media, name the participating institution, and present its logo on its website and social media posts.
- The participating institution agrees to prepare and share a one-page summary about their experiences in participating the learning project upon its completion, and allows EDUardo to share this summary.
- Data handling of the Social Impact Program is done according to the general privacy policy of EDUardo.
- If any part of the conditions defined in this document is breached by the participating institution, EDUardo can cancel the support of the learning project with immediate effect.
- EDUardo reserves the right to suspend or cancel the Social Impact Program any time.
- The Social Impact Program is governed by the Laws of Hungary.
- In case of other topics not covered but are relevant to the program, the "GENERAL TERMS AND CONDITIONS HIGHER EDUCATION INSTITUTIONS" of EDUardo is applicable.
